CARAVAGGIO'S SONG shadowed the early pace from the two path, applied pressure after the half mile marker, did battle in the upper stretch until driving clear in the final furlong. PHOEBEINWONDERLAND was loose on lead in the early stages, came under pressure from CARAVAGGIO'S SONG after half, grudgingly gave way at the eighth, just held for second. OPERA DE RAVEL (FR) settled off the pace, trailed briefly in the far turn before making a bold move in the upper stretch, rallied three wide to just miss the second. LADY FROST settled off the pace along the the inside, shifted out four wide at the top of the stretch, closed willingly. COCKTAIL KISSES tracked the pace three wide, flattened out in the stretch. BACKSEAT ROMANCE was rated along the inside, got outkicked. D DOLLY'S GIRL trailed for most, passed tiring foe. MADAM PROSECUTOR found early placement around the middle of the pack, retreated through the far turn.
