TEDDY BEAR showed the way along the inside, shook clear leaving the quarter pole and drew off on his left lead. MORAL POWER pursued from midpack in the three path and between horses, swung out to the six path into the lane, rallied on his left lead and gained place late. ALEXANDER K prompted outside of the eventual winner around the turn, proved no match nearing the lane then lost place late. NIGHT RAVEN laid off of the pace in the five path, advanced turning for home, tucked to teh inside into upper stretch and sustained progress to edge fourth. POLIZON raced close up along the inside, chased in the two to three path around the turn then gradually yielded between horses. ILLUSTRATION tracked in the in three path, chased in the four path into the lane and lacked a bid. BOWIE hopped slightly at the start, pursued from the two path and failed to factor. SHOO IN raced off of the pace in the two to three path, swung out to the five path into the lane and lacked a rally. COASTAL APPEAL chased forwardly in the four path then faded between horses around the turn. RAGEVILLE leaned inwardly and took up at the start, trailed in the two path and got outrun. BEYBE BETO pursued from midpack in the five path,

but sustained an injury at the three furlong pole, was pulled up turning for home and transported off of the track in an equine ambulance.
