SHIELDMEWITHPRAYER set a pressured pace along the inside past the quarter pole, gave up a narrow advantage to the runner up nearing the top of the stretch, dug in gamely under left handed urging and got back up in time by the narrowest of margins. GOSHEN stalked the pace three wide while hung out in the six path down the backstretch, rallied to make the lead nearing the top of the stretch, dueled with the winner to the wire and just missed hanging on. CALISUE saved ground and went evenly. DREAMING OF AUDREY pressed the pace two wide while racing in the five path down the backstretch and weakened in the lane. UNA ROCA hopped and broke in a tangle and was never close. THE STEWARDS POSTED THE INQUIRY SIGN BUT TOOK NO ACTION.
