INEEDYUBABE trailed early, circled rivals four wide on the far turn, drifted inward under right handed urging past the three sixteenths pole, drew on even terms for the lead inside the furlong maker and proved best by the narrowest of margins. WONDER WORLD stalked the pace along the inside, made the lead in upper stretch, dug in gamely when joined by the winner and just missed hanging on. PARLAY hopped at the start, vied for the lead three wide into the stretch, was squeezed between rivals just past the three sixteenths pole, checked and angled outside then faded. ANOTHERHOPE set the pace along the inside into the stretch, drifted out past the three sixteenths pole and weakened late. TEMPORARILYFOREVER pressed the early pace two wide and gave way on the far turn. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF PARLAY LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLEGED INTERFERENCE AT THE TOP OF THE STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGINAL ORDER OF FINISH.
