MASTER OF THE NITE unhurried for five furlongs, rallied six wide through upper stretch to make the lead at the furlong marker and proved best under right handed urging. PUFF'SMAGICDRAGON allowed to settle, loomed boldly four wide in upper stretch then couldn't get past the winner. KYKEON chased the pace two wide, surged to the front at the quarter pole, set the pace until mid stretch then was outfinished. PATRIARCHAL trailed into the stretch and improved position along the rail. GOSHEN stalked the early pace, offered a mild bid three wide nearing the quarter pole, shifted five wide then came up empty. STRIKE APPEAL failed to menace. DR SCHUSTER away alertly, set the pace along the inside for six furlongs then gave way.
