STRATEGIC PROFILE close up from the start, slipped through along the rail to gain a narrow lead at the seven sixteenths pole, drifted out bumping the runner up in upper stretch, was coxed with a right handed crop inside the furlong marker, exchanged bumps with WATER INTO WIN under a strong hand in the late stages and proved best by a narrow margin. WATER INTO WINE battled for the lead two and three wide, was bumped by the winner in upper stretch, matched strides with that one the balance of the trip, exchanged bumps in deep stretch and was denied. R U ENTICED raced four wide early and improved position late three wide. MARK MY WORDS dueled for the lead along the inside through the second turn then weakened at the top of the stretch. LEAVETHENINETY NINE was leaning on the gate, hopped then veered out at the start and was never involved. JOLLY MON failed to menace. RICO SUAVE stalked the pace along the inside into the second turn then gave way. COWGIRLSLUVME had no impact. GLOBAL EVENT had speed for a half, stopped on the far bend, was eased in upper stretch, walked to the wire and was walked off. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF WATER INTO WINE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLGED INTERFERENCE IN THE STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGIINAL ORDER OF FINISH.
