NO INDULGENCE set the early pace two wide, was headed nearing the turn, drifted to the six path at the top of the stretch, came on again to regain the advantage before the furlong marker, drifted in a bit late despite left handed urging and drew off. GAMAY pressed the early pace along the rail, gained a narrow lead nearing the turn, drifted to the four path at the top of the stretch, steadied near the sixteenth pole then was no match for the winner. LADY SWEET trailed early, improved three wide in upper stretch, drifted in causing the rider of MARTINEZ MOJO to check hard at the eighth pole and finished clear for third. SPILL THE DEETS saved ground and lacked the needed response. MARTINEZ MOJO raced two wide into the stretch, was shut off at the furlong marker, checked hard between horses and lost momentum. MODO SALVAJE had brief speed three wide. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF GAMAY LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLEGED INTERFERENCE IN DEEP STRETCH. AFTER REVIEW THE STEWARDS TOOK NO ACTION ON THE FOUL CLAIM HOWEVER DISQUALIFIED LADY SWEET FOR INTERFERENCE IN MID STRETECH AND PLACED HER FIFTH.
