EKATI'S WAY pressed the pace two wide into the stretch, drifted out to the six path, made the lead nearing the furlong marker, drifted in slightly under right handed urging nearing the sixteenth pole and finished full of run to win going away. FAIR AND SQUARE set the pace along the inside into the stretch, drifted out to the four path, steadied and shifted outward after the winner passed then was no match while well clear for second. SILENCE void of early speed, found his best stride late in the five path. ROMANIAN PRINCE was restless in the gate, hopped at the start then had no impact. HENRY MAC stalked the pace along the inside into the stretch then weakened. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF FAIR AND SQUARE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLEGED INTERFERENCE IN MID STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGINAL ORDER OF FINISH.
