FORTISSIMO vied for the lead along the inside through the turn, slipped through to make the lead at the three sixteenths pole then drew clear under left handed urging and won under strong handling. MR. PENNY PINCHER well placed, dug in five wide through deep stretch and got up for second. ATKINS drifted inward causing LOU'S LEGACY to clip his heels leaving the chute, was allowed to settle then improved position late four wide. VODKA N GINGERALE unhurried early, finished with good courage along the rail. REAL NAUGHTY pressed the early pace along the inside, made the lead past the half mile marker, set the pace to the top of the stretch then was outfinished. KONTEEKEE had no impact. RUFFIN set the early pace two wide and weakened in the lane. MY BROTHER CAM was no factor. LOU'S LEGACY was in tight and clipped heels leaving the chute then was never involved. THE RIDER OF LOU'S LEGACY LODGED A CLAIM OF FOUL AGAINST THE RIDER OF ATKINS FOR ALLEGED INTERFERENCE LEAVING THE CHUTE. AFTER REVIEW THE STWARDS TOOK NO ACTION.
