MOTOWNSNOJOKE close up from the start, loomed boldly three wide nearing the quarter pole, shied inward when struck with a right handed crop in upper stretch, the rider quickly switched to left handed urging then was no match for the winner. BOX OFFICE HIT inside, drifted drifted out to the four path in upper stretch and went evenly. MADDY'S FURY stalked the early pace three wide and was through after a half. BEA BOLD was no factor. ICE BEE was outrun. MICHELLE MY BELLE had speed into the turn then wilted. CHICABEE had no impact. TIME TRAVELER had speed into the turn then stopped.
