CROSSED UP pressed the early pace three wide, took over entering the turn, shook clear before the quarter pole, drifted to the six path in upper stretch then couldn't handle the winner. CALI CRUISER battled for the lead along the rail down the backstretch, dropped back on the turn, shifted, swung wide then finished evenly in the seven path. LADY LOTTIE battled for the lead two wide to the turn, kept on into the stretch and weakened late. BUCKEYE CRUISER stumbled badly at the start and was no factor. MOBIL LADY failed to menace. BIG FACTS reared at the start, unseated her rider a few strides later and was walked off. THE STEWARDS POSTED THE INQUIRY SIGN BUT TOOK NO ACTION.
