COUNTEVERYBLESSING had a narrow lead along the rail on the clubhouse turn, kept pressure down the backstretch, shifted three wide nearing the second turn, surged late under right handed urging making the lead in deep stretch and edged clear under strong handling. LAW OF THE JUNGLE never far back, loomed boldly along the rail entering the stretch then finished second best. MR. PENNY PINCHER had good early speed three wide, dropped back on the backstretch, came on again four wide on the far turn then was outfinished despite a determined effort. PANTHERA'S FATE set a pressured pace two wide then along the inside until mid stretch then was outfinished. WASHINGTON'S UNION failed to menace. BOURBON ON FIRE allowed to settle, offered a mild bid five wide on the second turn then came up empty. VINCENZINO pressed the pace three then two wide into the far turn then flattened out.
