COUNTEVERYBLESSING allowed to settle settled, closed willingly four wide through deep stretch under left handed urging and was along in time. MY BROTHER CAM pressed the pace two wide around the first bend, made the lead before three furlongs, set a pressured pace into the stretch, drifted out from the two path to the five path inside the furlong marker after being put to a left handed crop then couldn't handle the winner. DIXIE'S TWO STENTS trailed for five furlongs then finished determinedly along the rail. BOLD BUCKEYE set the pace along the inside through the first turn, dropped back before a half, shifted out three wide on the far turn, came on again before the quarter pole, battled until deep stretch then was outfinished. WE NEED A FAVOR pressed the pace three then two wide into the stretch, was shut off by the drifting leader inside the furlong marker, checked hard and lost momentum. ONLY GET'N BETTER with the second flight two wide, was through after a half. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF WE NEED A FAVOR LODGED CLAIMS OF FOUL AGAINST THE RIDERS OF BOLD BUCKEYE AND MY BROTHER CAM FOR INTERFERENCE IN THE STRETCH. AFTER REVIEW THE STEWARDS DISQUALIFIED MY BROTHER CAM AND PLACED HIM FIFTH.
