QUARANTINO pressed the pace two wide past the quarter pole, made the lead at the top of the stretch, shook clear under left handed urging and lasted under right handed encouragement. HEART OF AN ANGEL stalked the pace into the stretch and was steadily gaining ground on the winner in the final stages while racing in the four path. ROYAL DECADENCE close up early, dropped back on the turn then came on again late two wide. TIZ RUDDY BEN well placed, failed to respond. ISLAND BOSS away alertly, set a pressured pace along the inside to the top of the stretch then was used up. PER RULING #2025-21592 FROM HISA, QUARANTINO WAS DISQUALIFIED FROM FIRST TO UNPLACED DUE TO CROP MISUSE.
