## Footnotes | View Glossary Of Terms

WORTHY OPPONENT never far back, dug in determinedly late under left handed urging while three wide and got up in time. CAVALETTO never far back, rallied determinedly four wide in deep stretch and got up for second. RUMBLE STRIP RON chased the pearly pace along the inside, offered a strong late bid inside rivals and was outfinished. LUNCHATTHELIZARD sprinted to a clear lead soon after the start, set the pace until deep stretch then was outfinished while two wide. A PRAYER FOR KIDS failed to menace. TEAM LEYENDECKER wide early, passed tiring rivals. HEY EUGENE had speed into the turn then weakened. HARTSTEIN stalked the early pace three wide and was through after a half. YIPPEE KI YAY allowed to settle, suffered and injury on the turn, pulled up at the top of the stretch then was removed from the racetrack via equine ambulance. THE STEWARDS POSTED THE INQUIRY SIGN BUT TOOK NO ACTION.
