P H FACTOR chased the leader while under a firm hold into the far turn, rallied two wide under left handed urging to make the lead inside the furlong marker and edged clear late while drifting in towards the rail. JOHN'S ROCK well placed, rallied through the stretch three wide and got up for second. DR SCHUSTER broke in front and quickly opened a daylight lead, set the pace until mid stretch, steadied inside the winner nearing the wire and was outfinished for second. CARILLO broke in a tangle, settled well back and rallied determinedly through the stretch four wide. ROYAL DRAGOON trailed. THE RIDER OF DR SCHUSTER LODGED A CLAIM OF FOUL AGAINST THE RIDER OF P H FACTOR FOR INTERFERENCE IN DEEP STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGINAL ORDER OF FINISH.
