Weights: Three-Year-Olds, 119 lbs. Older 123 lbs. Non-Winners of \$30,000 twice in 2025 allowed 2 lbs. \$30,000 in 2025 allowed 4 lbs. Of two races other than Maiden, Claiming, Optional or Starter in 2025 allowed 6 lbs. Nominations Close Monday, September 15th, 2025. Starters to be named through the entry box Thursday, September 18th, 2025. A Trophy will be presented to the Winning Owner. This stake will not split. In the event more than fourteen (14) horses pass the entry box at the time of closing of entries, preference will be given to those horses having accumulated the highest 2024-2025 earnings as published by Equibase. VILLIAN prompted the pace two wide into the stretch, made the lead near the furlong marker and drew off under confident handling. SHADOWY set a slow pace inside the winner to mid stretch then was no match while clearly second best. COUNTEVERYBLESSING stalked the pace along the inside and held on for third by a narrow margin. CASUAL ATTIRE stalked the pace four wide and went evenly. THAT'S THE WAY was bumped hard by RONNIS SECOND WIND at the start then failed to menace. RELISH THE RIDE was no threat. BOLD BUCKEYE raced five wide and lacked the needed response. MISTER MOBIL was no factor. RONNIS SECOND WIND lost his action, bumped hard into THAT'S THE WAY at the start and unseated his rider. THE STEWARDS POSTED THE INQUIRY SIGN AND AFTER REVIEW UPHELD THE ORIGINAL ORDER OF FINISH.
