SMOKIN' HOT never far back, moved closer three wide on the turn then leveled off. CLASSIC RICHIE bumped at the start, settled within striking distance along the inside then failed to respond. PLATINUM GHOST bumped at the start, had speed two wide into the turn then wilted.
