LATE NITE LIZZIE was never far back while three wide, had a mild bid late while no threat. LUBU was never far back while three wide, lacked a late response. WICCA WISDOM allowed to settle, failed to menace. SACRED CONNECTION trailed. The rider of LATE NIGHT LIZZIE claimed foul against the rider of DREAMING OF AUDREY for alleged interference on the far turn. After viewing the tape the stewards took no action.
