KICKSTART bobbled at the start, pressed the pace two wide, took over midway on the bend, drifted to the five path entering the stretch and edged clear under right handed urging. BLAZING TONY never far back, offered a mild bid three wide into the stretch and finished well clear for second. BISCUITS 'N GRAVY settled two wide, altered course to the eighth path in upper stretch bumping with HEZA PISTOL then improved position late. HEZA PISTOL stalked the pace three wide into the stretch, was bumped by BISCUITS 'N GRAVY into OLLIE'S FOLLY i upper stretch then checked hard and lost momentum. OLLIE'S FOLLY raced four wide into the stretch, was bumped from his inside in upper stretch, checked and also lost momentum. CORFU FIGHTING stumbled at the start, rushed to the lead along the inside, set the pace until the middle of the turn, kept on into the stretch and weakened late. SADIE'S SILVER KID wide early, was through after a half. THE RIDER OF HEZA PISTOL LODGED A CLAIM OF FOUL AGAINST THE RIDER OF BISCUITS 'N GRAVY FOR INTERFERENCE IN UPPER STRETCH. AFTER REVIEW THE STEWARDS DISQUALIFIED BISCUITS 'N GRAVY AND PLACED HIM FOURTH.
