CORNER OFFICE vied for the lead along the inside, responded readily when set down, slipped through along the rail to make the lead at the top of the stretch and edged clear late under right handed urging. PROSECUTOR away alertly, set a pressured pace three then two wide, dueled through the turn and into the stretch and gamely held on for second while two wide. MAY MAYHEM settled inside, angled out four wide in upper stretch and was steadily gaining ground late. WETZEL raced four wide down the backstretch, battled two wide through the turn and into the stretch then was outfinished. SAMMY'S SMILE trailed into the stretch, swung wide and passed tiring rivals. LITTLE TOY GUNS had no impact. MUTINY pressed the pace two wide then along the inside into the turn then weakened. TURNING PAGES well placed, failed to respond. IRONCLAD ALIBI had speed into the turn then gave way.
