Nomination fee of \$50. \$262 to enter with an additional \$488 to start, with a purse of \$75,000, of which 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Weights: 118 lbs. Nominations Close Monday, September 29th, 2025. Starters to be named through the entry box Thursday, October 2nd, 2025. A Trophy will be presented to the Winning Owner. This stake will not split. In the event more than fourteen (14) horses pass the entry box at the time of closing of entries, preference will be given to those horses having accumulated the highest lifetime earnings as published by Equibase. DYNAMIC VISION pressed the pace to wide past the quarter pole, made the lead at the top of the stretch, drifted in a bit under right handed urging before the furlong marker, drew clear, drifted out when her rider changed to a left handed crop near the sixteenth pole and won under a strong hand ride. SPUN IN DOMINUS never far back, loomed boldly three wide nearing the top of the stretch, gave up ground to the winner before the furlong marker, shifted inside that one near the sixteenth marker and finished second best. PERFECT ANGEL never far back, finished with good courage four wide. DUNN'S RIVER forwardly place from the start, moved closer two wide on the turn then failed to sustain that bid. STRIKING LADY gained a narrow lead soon after the start, set a pressured pace along the inside to the top of the stretch and faded late. JUST RUNNIN was no threat. MISS LORA ANN was no factor. HER OWN SHADOW bobbled at the start, rushed to contention along the rail soon thereafter, had speed into the turn then weakened. THE RIDER OF SPUN IN DOMINUS LODGED A CLAIM OF FOUL AGAINST THE RIDER OF DYNAMIC VISION FOR ALLEGED INTERFERENCE IN DEEP STRETCH. AFTER REVIEW THE STEWARDS UPHELD THE ORIGINAL ORDER OF FINISH.
