THE RIDER OF PRINSIPITO LOEDGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR ALLEGED INTERFERENCE AT THE QUARTER POLE, AFTER REVIEW THE STEWARDS UPHELD THE ORIGINAL ORDER OF FINISH.
