PETER FLIES dueled for the lead for three furlongs then was collared by the winner bur saved enough to hold second. MATTAWA N THAT chased the pace, was fanned four wide to the stretch and lacked the needed late response. DOMINATE got outsprinted, raced three wide and did not rally. BUZZED BY A TIGER had no speed and was always outrun. THE LAIR had brief speed and gave way. ROJO PEQUENO was jostled between rivals at the start then was dull.
