DRAW THE FOUL disputed the pace for three furlongs then inched away from CORN POP on the second turn and drew clear in the drive. CORN POP attended the pace outside the winner, got outkicked after a half mile then was easily second best. DOUBLE PERFECTION chased the top two for a half while three wide then lacked the needed late response. GIANOLA had his heels clipped by MORRO MORRO into the first turn and trailed. MORRO MORRO clipped heels with GIANOLA into the first turn and fell.
