MISCHIEFS CAUSEWAY had good speed, dueled the runnerup through four furlongs, came into the stretch in second but battled on gamely to prevail. DOMINATE dueled the winner for a half mile, took a short lead into the stretch then could not hold on. RAAJIN RIBBON tracked the leaders, was outkicked after four furlongs and finished evenly. ANTICIPATED had no speed and was not a threat. HAIL STATE bobbled at the start and gave a dull effort.
