## Footnotes | View Glossary Of Terms

DISCREET OPS, four deep the first turn, left the backstretch three wide, drifted in and bumped with HAPPY CLOUDS mid way on the far turn then asserted herself under brisk urging and drew away. CHAPA, a forward factor in the three path between horses the first turn, prompted pace, raced in the two path entering the far turn, was bumped and forced in by the winner mid way on the bend and held the place. HAPPY CLOUDS, lightly bumped by GINGER GIRL leaving the starting gate, moved to the inner rail leaving the backstretch, steadied in tight quarters inside CHAPA mid way on the far turn, swung out in upper stretch and finished willingly. GINGER GIRL lightly bumped HAPPY CLOUDS when drifting out at the start, remained along the inner rail the first turn and weakened leaving the backstretch. An objection by the rider of CHAPA against DISCREET OPS for alleged interference on the far turn was not allowed. Ann objection by the rider of HAPPY CLOUDS against CHAPA for alleged interference on the far turn was not allowed.
