## Footnotes | View Glossary Of Terms

GROSSE ILE ducked out sharply at the break, corrected and sped up three deep to take a slim lead, shook well clear heading into the turn, shifted inside, kept on under left handed asking past the sixteenth pole and dug in to deny NEW YORK LIGHTS. NEW YORK LIGHTS vied inside the winner early on, eased out and chased around the turn, advanced into the lane, kept on gamely but was kept at bay. BELLA CREED flashed speed inside foes, could not quicken with the leaders near the three eighths, eased out to chase two wide, drifted four wide around the turn, corrected for the drive and rallied. RIO OSO, bumped and pinched back at the break, dropped well off the early pace, saved ground into the lane and finished with effort. CAYUGA broke outward and bumped with a rival, drifted out a bit into the turn, shifted in and faded.
