DAME LAURA laid off the pace two wide and between horses, moved to the inside with five furlongs to go, saved ground in pursuit around the far turn, slipped through to offer a rail bid entering the lane and drew off. LIVEOAKS VIEWPOINT raced close up two wide and between horses, chased in the three path around the far turn, moved inwardly in upper stretch and ran on to edge place from an outer foe in the final furlong. CONCEIT stalked in the five to four path around the first turn, prompted the top pair with five furlongs to go, sustained pressure in the four path rounding the far turn, but got outkicked by, and proved no match for, an inner rival reaching the lane then yielded place late. TEARIN'UP MY HEART lacked speed along the inside, retreated to trail at the five furlong pole, swung out to the six path at the furlong grounds and moved up. KRISSYS STAR steadied between horses entering the first turn, laid off of the pace three wide, then in the four to five path turning for home and failed to factor. IVY GARDEN raced at the rear two wide early on and failed to menace. RED BERETTA vied along the inside, led in the two path around the far turn, but got headed by an inner bidder entering the lane and weakened between horses. CALIFORNIA SMOKE vied three to two wide early on, led narrowly between horses with five furlongs to go, got headed by her inner counterpart while in the three path into the far turn and weakened. ZEN YOGA stumbled at the start and dislodged her rider. A STEWARDS' INQUIRY REVIEWING THE START RESULTED IN NO CHANGE TO THE ORIGINAL ORDER OF FINISH.
