FANTASTICAL tracked from the three path, moved to the inside into the backstretch, tipped to bid three deep turning for home, gained an advantage entering the lane, got collared by an outer challenger in the final sixteenth then brushed that one while holding at the wire. GOLDEN SUNSHINE raced at the rear in the three path, took closer order approaching the far turn, chased while coming under urging in the four path turning for home, yet rallied to bid outside of the leader in the final sixteenth, took light contact and missed at the wire. TAKEMETOTHEBEACH brushed an inner foe at the start, stalked along the inside before moving to the two path into the backstretch, bid two wide into the far turn, led briefly turning for home, but got outkicked by an outer bidder entering the lane, lost place shortly after then held show. GIRL OF MY DREAMS set the pace along the inside into the backstretch, got headed by an outer bidder approaching the five sixteenths pole then faded. LOVE HER LOTS took contact from an outer foe at the start, raced at the rear in the two path, then in the three to four path around the far turn and failed to menace. JUST AN OPINION pursued from the four path before tucking to the two path into the backstretch, chased around the far turn and gave way.
