SALT stalked along the inside, shifted to the five path to take aim on the top pair in upper stretch, bid at the furlong grounds then edged clear. FAMILY vied two wide, dueled in the four path in upper stretch but got outkicked by an over bidder at the sixteenth pole. KISS ME AGAIN trailed along the inside, swung out eight wide in midstretch and rallied on her left lead to reach show. SAPHIRA raced off the pace in the two to three path, advanced between horses in the final furlong and missed show. ELLE'S DANCER chased in the four path, fanned out to the seven path into the lane, stayed on the needed more for show between horses late. FANCY FASCINATOR brushed with an inner foe at the start, vied for the lead with an outer rival into and around the turn, dueled through midstretch, got outkicked at the sixteenth pole and faded. COMMANDED was brushed by an outer foe at the start, chased in the three to two path and lacked a bid. COTILLARD saved ground off of the pace then tired. PATTY VAN TWINKLE pressed three wide, floated to the five path into the lane then weakened between horses. BELLAVININO raced off of the pace in the five path then got outrun.
