REB FIVE progressed between horses at the nine sixteenths pole, stalked the top pair from the two path, tipped to take aim from the four path at the quarter pole, bid in upper stretch then drove clear while hanging on his left lead. UNCLE BUCKY lacked speed along the inside, shifted to the three path around the turn, progressed while swinging six to seven wide into upper stretch then rallied to reach place late. MOM'S SPAGHETTI tracked from midpack in the four path, progressed in the three path and between horses in the final furlong, bid for place along with an outer rival in the final sixteenth but got outkicked. JUDICIAL REVIEW vied for the lead with an outer rival, led into the lane but got headed by an outer challenger at the furlong grounds and faded. CANTERVILLE vied for the lead with an inner rival while kept in the three path, yielded between horses in upper stretch then gave way. NINE BALL lacked speed in the four path, shifted to the six path and between horses in upper stretch and failed to factor. SOMETIME chased along the inside then gave way. YORQUICK lacked speed two wide and made little impact. VAPORIZER tracked from the five to three path into the turn, chased while moving back to the five path in upper stretch then faded between horses.
