B B PRINCE lacked speed in the four path, fanned out to the seven path entering the lane, yet rallied widest to reel in the leader in the closing stages. STONEMONT REUNION tracked in the three path and between horses, ranged up four deep at the quarter pole to offer a bid entering the lane, forged an advantage in upper stretch, held sway into the final sixteenth but got caught late. STOLEN POWER was off slow, pursued from midpack in the two path,

inched closer turning for home, shifted to take rail aim in upper stretch, but was kept at bay through midstretch, got outkicked in the final sixteenth then was denied place and saved show. TAUNTING pursued from midpack in the four path, shifted five wide into the lane, ran on but got outkicked for a minor placing at the sixteenth pole then missed show. MARSHAL pressed two wide and between horses, vied down into the far turn, forged an advantage at the three furlong pole, sparred with an outer pair at the quarter pole but got headed in upper stretch and gave way between horses. CONCRETE CRUISER settled off of the pace in the three path, chased in the four path and between horses into the lane then moved up. VULCAN'S BOOTS trailed in the three path, then along the inside around the far turn, shifted five wide into the lane and failed to factor. BILLY WHITE SHOES (IRE) lacked speed in the two path and made little impact. AUBREY'S MAX tracked along the inside, chased in the two to three path and between foes in upper stretch then gave way. PHILA STREET stalked three wide, bid and vied around the far turn but got outkicked between horses entering the lane and weakened. JUJUBEE set the pace along the inside, got headed by an outer pair at the three furlong pole then faded turning for home.
