BURNING LEAVES bit tardy from the gate, no speed to the turn with a good run to clear. RANSOMWARE speed to the front outside, stayed game in the stretch. BREAKWATER good position to stretch, rallied on for the show spot. RACE DAY REBAL good position throughout with no late kick in the drive. PRICHARD chased leader to quarter pole with nothing left and faltered. MR. PETERKIN never a serious threat throughout. MY CALANTE outside run while evenly and never menaced throughout. COACH CAMPBELL good position to the stretch, could not go on and faltered late. LINK TO DESTINY outside to turn while never a threat. CREPE YARNS good position to quarter pole, emptied out and dropped back.
