SPIRIT OF A WALKON sharp speed to front, well handled throughout to hod sway late. MAGAMAK no speed early on with a steady run to far turn, gaining. POWER BOOST no speed from gate, good position from half, chased, kept show. OTZELBERGER unhurried to far turn, rallied on into stretch, leveled off late. DURABLE well back to far turn ran on to improve position only in the lane. BURDEN OF DREAMS raced between horses backstretch in good position with no kick. NOBLE COURT no speed throughout with wide run past quarter pole, no real gain. SURVIVIN'ONAPRAYER inside run first turn and never menaced throughout. LOVE POTION slow into stride and never factorered throughout. CHUCK'S LAW inside run to far turn while close up, gave in readily

stretch. BIG BOY THUNDER pressed pace between horses to far turn with nothing left stretch. INTROUBLEAGAIN split horses in first turn to contend to the half, emptied out.
