## Footnotes | View Glossary Of Terms

EMERSON'S DREAM unhurried to half launched a bid far turn, kept on all out up. I MADE IT quick to the front while well handled throughout, outkicked late. CEEBEE saved ground to far turn, glided up four wide far turn, improved. PEACOCK ROAD angled over first turn well back, ran on to far turn, steady run. SHAMU raced well back to far turn with improvement in the stretch run. CORA'S LEGACY chased pace between horses to far turn leveled off with no gain. LUCKY SHORE three wide chase to far turn, bid stretch, flattened out late. JOLLY JUSTICE no speed to the half outside run past quarter pole, no factor. SOLRUN inside run to quarter pole close up, failed to sustain bid, empty. DECREE outside run to far turn close up, nothing left in the stretch run. COUNCILWOMAN JILLY reared at the start and lost best chance and kept in as a starter. After a steward inquiry into the start there was no action taken,

COUNCILWOMAN JILLY WAS DEEMED A STARTER.
