PAUL'S GUITAR good position to turn, rallied in earnest to clear late and hold at the wire. GO COLLECTOR pressed pace early, drew off turn. well clear stretch, run down. SIERRA POWER no speed to turn, rallied along stretch for the show spot. POINT BARROW raced along evenly with no response in the stretch. MITOLA good position to the turn with nothing left and faded back. HEY BATTER BATTER awkward start no speed to the turn and failed to respond from there. SPINNING SPIRIT pressed pace early on, gave way readily in the turn. ALTER BOY stumbled at the start and never recovered. BORIS BADENOV through early outside and faded back.
