SPASTIC BID unhurried early, ran up to the half, kept on good handling clear. LADY FAYE good position inside behind leaders, rallied on stretch no match. SWEET MAGNOLIA no speed to far turn, improved position in stretch missed place. ZAFYRE ran up quickly to lead, stayed game to the stretch weakened third. HOPE RISING never a real menace throughout. VADORA ran around evenly lacking a response when needed. BECTIVE ABBEY quick speed to press for three quarters, gave way readily. SPUNHARDCANDY never factored throughout. FIRE always outrun. MESCOOL mild middle move, dropped well back in the stretch. HONORISIA always back. FIZZY GIRL tried to keep up for a hlaf, gave way readily thereafter.
