DEWY'S DENALI perfect trip to quarter pole, angled out, gamely cleared late. GO JACK GO good position to far turn, ran on in the stretch run leveled off. ABDICATE broke well outside to the front, led to quarter pole held show. ORGANIZED raced back to half, rallied into the far turn, evened out stretch.

GOLDEN HURRICANE raced along evenly with no response when needed. HOMEPAGE squeezed at the start, saved ground early on, mild improvement. HEAVENLY MATCH failed to menace throughout. INSPECTOR FRED never factored from the start. GO CHICAGO outsprinted to lead chased to quarter pole nothing left stretch. COMPULSIVE widest into first turn, dropped far back readily. ELZIE CLAYTON pressed pace in three path to half, gave way quarter pole.
