NO ORDINARY TIGER took command early and handled outer pressure, moved clear near the half, lost the lead while two wide into the lane, battled back under strong handling to reclaim the advantage a furlong out, kept on tenaciously from there and edged clear at the wire. SEAHORSE STAMPEDE saved ground, edged up nearing the far turn, tracked an embattled trio past the five sixteenths, angled out four wide into the lane, shifted back in a bit nearing mid stretch, kept on grinding and just got the place to the inside of CRUSHER ROYALE. CRUSHER ROYALE stalked in the clear, moved up into the far turn then bid three deep, dueled and gained a short lead entering the lane, wandered outward relinquishing command in mid stretch, stayed on to chase and gave way grudgingly. ATMOSPHERIC RIVER settled off the pace while saving ground, crept closer nearing the quarter pole, threatened towards the inner rail near mid stretch then flattened out. RATLEFF drifted out early, regrouped and raced between runners leaving the far turn, swung out nearing the furlong grounds but failed to follow through. RESULTANT , bumped and in tight at the break, lagged off the pace, saved ground into the lane, angled out and failed to threaten. CANCUN NATIVE was sent up four wide to contention, pressed into the backstretch then chased past half, came back on with a two wide bid soon after, battled between runners from the five sixteenths to the head of the lane and weakened. BOB'S DECISION , taken to rate early while saving some ground, angled out for the backstretch run but failed to get involved. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
