HELA FOREVER , bumped at the break, edged up and chased to the inside of rivals nearing the half, was scrubbed along with pursuit of the leader past the five sixteenths, moved through two wide and to the inside to engage in upper stretch, edged away under left handed asking leaving the furlong grounds then widened while steadily hand ridden in the final seventy yards. RENO sped clear early and wandered out to about the five path then corrected, was nursed along well off the inside around the turn, came under a ride approaching the stretch, failed to deny the inside bid of the winner, faded but remained well clear of the rest. PROWLING CAT , a bit reluctant to load, broke inward bumping the winner, gained inside under a ride mid turn, came out for the drive but lacked a serious finish through the final furlong. BOUNDLESS OPTIMIST broke sluggishly then ducked in towards the gap, regrouped and lagged well back while saving ground, eased out into the lane, split rivals past mid stretch and finished with good energy. AINT BEHAVIN , three deep chasing near the half, moved up a bit leaving the far turn, gave hard chase four to five wide into the lane, lacked a punch past mid stretch and faded. GRINNELL broke a step slow, found himself well back early while saving ground, made some progress while under a ride past the five sixteenths, came out for the drive but failed to sustain. SAND PAYNTER , bumped at the break, raced between runners early, saved ground into the stretch but lacked a rally. URBAN JUSTICE , four to five wide early on, failed to keep pace mid turn, came six wide for the drive and faded. LIL ANTHONY chased outside a rival early, raced four wide between foes into the stretch and faded. CONVEY TO ME chased between runners early then to the inside of a rival leaving the far turn, steadied soon after and

gave way.
