SUMMER LOVER saved ground off of the pace, progressed around the far turn, paused behind rivals nearing the quarter pole, rallied to slip through to issue a rail bid at the furlong grounds and kicked clear. FOR A LAUGH (IRE) tracked in the two path, roused between horses around the far turn, shifted out to the five path entering the lane, rallied along with an outer rival while getting floated out by an inner drifter in the final furlong, sparred for place with his outer co-bidding counterpart late and prevailed. DELIAN LEAGUE laid off of the pace in the three to four path, swung to the six path while building

momentum into the lane, rallied while getting floated outwardly in the final furlong, dueled for place with an inner foe through the late stages and missed. STRADIVARIAN stalked in the three path, bid two wide and between horses at the half mile pole, vied two wide rounding the far turn, but drifted out while getting outkicked by an inner bidder in midstretch, then yielded place to an outer pair late. DEAR SANTA stalked from the two path, took aim on the leaders from the three to four path in to the lane but lacked a bid. CRAFTY KING broke a step slow and bumped with an inner foe at the start, trailed near the inside and failed to menace. BROTHER REID lacked speed near the inside before moving to the two path around the first turn, pursued between horses at the quarter pole and failed to factor. LAW ABIDING showed the way along the inside, vied with an outer rival into and around the far turn, got headed between horses at the furlong grounds and faded. HOUSE OF LORDS broke a step slow, lacked speed in the three path, fanned out to the seven path into upper stretch and got outrun. LEVON broke slowly, bumped an outer rival and steadied at the start, tugged to progress in the four path around the first turn, bid three deep at the half mile pole but weakened between horses turning for home.
