COCKTAIL PRINCESS was brushed by an inner foe at the start, led narrowly while sparring with an outer foe into and around the turn, maintained a narrow advantage as the battle continued into the final furlong then lasted from bidders on either side at the wire. SONG OF SHADOWS brushed with an outer foe at the start, chased from midpack in the five path, rallied to gain place while running out of ground to catch the leader at the wire. LULA BELLA brushed with an inner foe at the start, dueled two wide, was kept at bay through the final furlong then lost place between bidders yet saved show. SMILING LADY bumped with an outer foe at the start, checked out of tight quarters among foes early on, laid off of the pace in the two path, shifted in entering the lane, rallied up the rail to miss show at the wire. GINGER IN CHARGE laid off of the pace in the three path, rallied two wide and between horses but encountered traffic through the final sixteenth. GO STORMIN GIRL stalked from the two to three path, chased the embattled leading pair from the final furlong into the final furlong, lacked a bid and yielded between foes late. PLEASINGLY bobbed and brushed an outer foe at the start, chased along the inside, moved out to the three path in midstretch and gave way between horses. B C CHU CHU checked when put to tight rail quarters approaching the turn, trailed in the two path, swung out to the eight path in midstretch and cut the gap on the rest belatedly. CHOCOLATE FRECKLES was bumped by an inner foe at the start, tracked in the four path and between horses then weakened.
