JIMMY B set the pace as an outer rival applied pressure, dueled with that one in upper stretch, clung to a narrow advantage as his counterpart gained even terms into the final sixteenth, leaned out and bumped that one in the closing stages then held. GOODFELLA (IRE) pressed two applied, continued to apply firm pressure rounding the far turn, dueled through midstretch and forged even terms passing teh sixteenth pole, but took contact from his inner counterpart late and hung. VERDI was fractious in the starting gate, stalked along the inside, shifted out to the four path in midstretch, slowly progressed on the embattled leading pair late but needed more. FLEET BROATO tracked from midpack two wide, chased while getting floated to the five path in midstretch then ran on mildly while hanging on his left lead. WARREN'S C J trailed two wide and failed to factor. ROWAN AUGUST lacked speed along the inside, chased in the three to four path rounding the far turn and made little impact. THE RIDER OF GOODFELLA (IRE) CLAIMED FOUL AGAINST JIMMY B ALLEGING INTERFERENCE IN DEEP STRETCH. FOLLOWING THE OBJECTION, AS WELL AS A STEWARDS' INQUIRY, JIMMY B WAS DISQUALIFIED AND PLACED SECOND. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
