COCONUT DREAMS came in after the start and caused trouble for a trio of inner foes early on, set a clear pace then held sway through the lane. MARK OF VICTORY was bumped between horses, pinched and steadied back soon after the start, lagged behind around the first turn, progressed four wide into the lane, rallied while hanging on his left lead to take aim on the clear leader in the final sixteenth but needed more to challenge. PINK CHANNEL took contact from outer rivals early on, pursued along the inside, shifted to the three path and between horses entering the lane, ran on before lacking room and steadying behind a foe at the furlong grounds, shifted out and kept on. RIDE ELBOW RANCH tracked two wide and between horses, chased along the inside around the far turn, moved out to the three path in midstretch then tired while hanging on his left lead. ELLIE MOORE (IRE) was floated inwardly by an inner rival soon after the start and forced to bump an inner foe before steadying back early on, tracked three wide, chased the clear leader two wide around the far turn and weakened. THE RIDER OF PINK CHANNEL CLAIMED FOULA AGAINST RIDE ELBOW RANCH ALLEGING INTERFERENCE IN MIDSTRETCH. THIS OBJECTION WAS DISALLOWED BY THE STEWARDS. THE RIDER OF ELLIE MORE (IRE) CLAIMED FOUL AGAINST COCONUT DREAMS ALLEGING INTERFERENCE AT THE START. THIS OBJECTION, AS WELL AS A STEWARDS' INQUIRY, RESUTLED IN COCUNUT DREAMS BEING DISQUALIFED AND PLACED FIFTH.
