FLASHY JEZEBEL pressed the top pair, vied two wide and between horses turning for home, shifted out to the four path into the lane, continued to spar with her inner counterpart through the final furlong and narrowly prevailed. MAX'S MAXINE vied two wide, led before being confronted by an outer pair at the five sixteenths pole, dug in and battled gamely through the lane but missed at the wire. BIG A'S LITTLE ONE tracked four wide and between horses, bid and vied three deep turning for home, got floated out to the five path while failing to maintain even terms entering the lane, then willingly chased the top pair home. MAXIMUM SPARKLE bumped with an inner foe leaving the gate, raced off of the pace three to four wide, crept closer after fanning six wide turning for home, but hung her left lead and flattened out. ROCKBAR stalked along the inside, steadied close up into the turn, chased in the two path around the bend and stayed on evenly. BANGO GAL tracked five wide and lacked a bid. ARMY KNIFE bumped with an inner foe at the start, trailed in the four to six path and failed to factor. IT HAPPENS chased in the two to three path and between horses then tired. QUE BELLA LUNA tugged under a hard hold to vie along the inside early on, but faltered with five sixteenths to go and readily stopped.
