SUPERMAX hopped at the start then was unhurried, moved up six-wide nearing the quarter pole, lacked room nearing the stretch then angled further out and was up in the final sixteenth. DEKUDYLAN settled in the back of the field early, rallied eight-wide into the stretch and finished fast. MALA was reserved off the early pace, moved up nearing the quarter pole while five-wide, took the lead entering the stretch but was unable to resist the top two-late in a game try. LIMITED HEATWAVE was in tight on the first turn when ITS PALADIN TIME got out then was allowed to settle, rallied three-wide into the stretch and finished well in a steady effort. WITHOUT EQUAL steadied on the first turn when ITS PALADIN TIME came out then was shuffled back, rallied seven-wide into the stretch and was gaining late. FIVE TWENTY SUNSET was forwardly placed racing two-wide, offered a bid nearing the quarter pole then was bumped by ITS PALADIN time nearing the stretch and finished willingly when clear. PLEASEUSETHEPORTAL saved ground while being allowed to settle and was unable to threaten. K R RULES settled in the middle of the field racing two-wide, steadied nearing the quarter pole lacking room, angled further out for the drive but was unable to seriously threaten. LET ME HELP YOU prompted the early pace racing two-wide and tired. ITS PALADIN TIME vied for the

lead from along the inside, drifted out on the first turn, then drifted out again leaving the quarter pole bumping with FIVE TWENMTY SUNSET and tired.
