EARL'S GIRL set the pace in the two path, rounded the turn under coaxing, hung on the left lead along the rail down the lane, but dug in to hold sway. SPARKLEY BARKLEY was prompted from up close in the three path, ridden around the turn, and ran on down the stretch to be second best. JOYRIDING raced off the pace in the two path, was driven around the turn, floated out to the four path passing the eighth pole, and kept on for show. ANGEL'S EFFORT was wellback in the two path early but improved along the rail down the stretch. TEN OF HEARTS broke out, rated from the five path into the turn, was cued in the four path passing the quarter, but made no impact from the six path down the lane. CHIPADA tracked inside, rounded the turn while being pushed along, but faded in the two path down the stretch. HOT SUMMER BREEZE chased in the three path, was ridden around the turn, but weakened. MYSTIC SKYE slowly broke out at the start and trailed throughout.
