ACCLAIMED PREACHER stalked the early pace while two wide on the backstretch, rallied on the far turn and assumed command at the quarter pole, was in a long drive and proved best in the end. YOGYA was allowed to settle while three wide on the backstretch, rallied on the far turn and was gaining ground in late stretch to finish well. ROUBAIX set the early pace while being well handled, was in a long drive on the far turn then weakened in late stretch. C HER BEAUTY was stalking the pace while inside, saved ground on the far turn then failed to menace in late stretch. GOLD COAST GIRL was unhurried early and raced four wide on the backstretch but failed to menace in the stretch. IN OPEN COURT was unhurried early while inside on the backstretch then was no threat in the stretch drive.
