LITTLE TROUBLE dueled for the lead while inside on the backstretch, was in a long drive then dug in and bore out in mid stretch and bumped with SHUT UP MICHAEL in mid stretch and held sway in late stretch. SHUT UP MICHAEL (IRE) dueled for the lead while two wide on the backstretch and into the far turn, was forced out in mid stretch then bumped with BAIE LONGUE and hung in late stretch to be second best. BAIE LONGUE was inside and stalking the pace, was in hand while racing off heels on the backstretch, made a bid three wide in upper stretch then was forced out sharply in mid stretch and bumped but came up empty in late stretch. SONIC SPEED was allowed to settled then raced inside on the far turn and was no menace in late stretch. MY MUNNINGS MODEL was unhurried early then failed to menace in the stretch. RIGHT HAND RYDER broke in the air at the start then was settled, rallied on the far turn and swung out to be five wide in upper stretch but was no threat. DEAR SANTA stalked the pace while three wide on the backstretch but faltered in the stretch. STOP AND A TRES was trailing throughout. A steward's inquiry was held concerning the stretch run. A claim of foul was lodged by the rider of SHUT UP MICHAEL (IRE) against the rider of LITTLE TROUBLE for interference in the stretch drive. After reviewing the film's, the steward's disqualified LITTLE TROUBLE from first and was placed third for interference in mid stretch.
